#### **General Contest Info:**

**Unit Check-in:** Units must check-in upon arrival to contest site to receive member wristbands for admission. No admission will be allowed to anyone not wearing a wristband or NNIA season pass (this includes unit entrance for volunteers).

**Tarps:** Unfolded performance tarps are allowed in warm-up areas as long as space allows without violating any fire codes. Please do NOT unfold tarps on a wet or dirty surface that will track these elements into the contest area on the bottom of your floor. Violation of this policy is subject to penalty and you will be financially responsible for any damage to the contest facility.

NNIA will provide a performance tarp for Concert and Standstill units.

**Equipment Inspection:** Located in ready area.

**Critique:** Critique sign-up times will be available at Unit Check-in. Please listen to your comments *prior* to your critique time.

**Sound Tests:** There will be no required sound check. If you require one, this will be available on the break between the percussion and guard competition.

Warm-up/Parking/Performance Area: All maps have been provided. Units should be on-site no later than one hour prior to performance time. Units must maintain the posted schedule for Warm-up and Ready Areas regardless of any delays in the Performance times.

**Announcements:** The Announcer will introduce each unit as they are entering the performance area. Announcer will then wait for unit director to cue "x unit, you may now take the floor in competition."










# WINTER REVIEW COMPETITION AREA DIAGRAM
